About Hands & Voices

H&V is a parent-driven organization dedicated to supporting families with children who are deaf or hard of hearing (DHH) from birth through high school. They provide resources, outreach activities, opportunities for parent/professional collaboration, and advocacy focused on helping children who are DHH reach their highest potential.

There are currently 42 authorized chapters of H&V across North America and several more in development. Each chapter has a parent leader who works directly with families.

In addition to support, services, and advocacy efforts, H&V offers the following:

- **[H&V Guide By Your Side Program](#)**: Direct family support from specially-trained parents of children who are DHH, including those who are deaf-blind
- **[H&V Advocacy Support and Training Program](#)**: A program provided by trained advocates, with content derived from direct advocacy experience working with families in schools, advocacy training from legal experts, and the H&V Educational Advocacy Book
- **[The Family Leadership in Language and Learning \(FL3\) Center](#)**: A technical resource center that works in partnership with family leaders, DHH adult leaders, and EHDI systems of care professionals

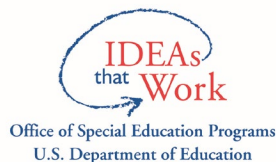
