

# Resources for Improving Transition Outcomes: Transition Outcomes Peer Learning Community

The Transition Outcomes PLC is made up of state deaf-blind project personnel, Helen Keller National Center staff, and National Family Association for Deaf-Blind representatives. The PLC focuses on increasing transition outcomes for students who are deaf-blind and have intensive support needs through state systems exploration and activities.
